Welcome to issue **#17** of the South Queensland Conference Corporate Crisis Management Team communication.

Church update

As of 1am Saturday 8 August 2020, Queensland closed its borders to New South Wales, the Australian Capital Territory and Victoria. "All visitors will be denied entry except for rare exemptions and returning Queenslanders will have to **pay for 14 days mandatory hotel quarantine**. People who live in communities on the Queensland-New South Wales border will be able to travel within the border zone for any reason." ~ Annastacia Palaszczuk.

Two weeks ago a number of individuals returning to QLD disregarded 'hot spot' protocols giving rise to the possibility of a second wave. The result was the immediate lockdown of all Aged Care facilities, closure or restaurants and cafés, some schools and SDA churches in the Brisbane Metro South Region.

"Queenslanders have done an amazing job in recent days. But we're not out of the woods yet. **Now is not the time to undermine our strong health response**." ~ Annastacia Palaszczuk.

The Conference Crisis Management Team resonate with Queensland Government's advice and urge church members to keep up 1.5m social distancing practices, good hand and personal hygiene and to get tested at the first sign of symptoms.

We have a moral duty to work together as participants in the solution and not the problem.

Churches in the South Brisbane region **may re-open again**. Our churches and ministries in Queensland are urged to take COVID-19 management seriously while we are in the process of re-opening our premises and to be proactive in measures taken to prevent viral contamination and transfer.

Churches are reminded about **indemnification**. Churches are required to follow current regulations as set out by the Queensland Government and the South Queensland Conference in order to receive indemnification. If a church chooses not to follow directions outlined by the South Queensland Conference then indemnification cannot be guaranteed and churches leave themselves personally exposed.

Closing and re-opening of Church as required:

We are living in uncertain times and the ever changing landscape of COVID-19 affects decisions regarding the closing and opening of churches. We ask that our members remain **patient and understanding** through this process and consider the very likely possibility that fluctuations and directives to churches may change on a more regular basis as we work through this uncertain environment and modify as needed. The CMT unfortunately **cannot guarantee what to expect next**. However, the decisions made to

close and re-open churches is based on **protecting the health and safety of our church members** and the surrounding communities we serve. Decisions reached are not made lightly, and are communicated quickly to our churches.

Therefore, please be prepared for further future changes in the closing and re-opening of churches as we monitor the movement of COVID-19 in our communities. Any changes in the community will be responded to as needed on the basis that the team is risk adverse and unwilling to sacrifice church member health and safety.

Church COVID-19 Policy and Risk Assessment:

- The Conference Compliance Department has developed a **COVID-19 Policy** for all Churches, Convention Centres, Bookstores and Administration and Resourcing Centre to follow. This will be available on the Safety Management System Website or contact the Compliance Department for a copy.
- **Church Low Risk Or Common Activities Risk Register** is also available on the Safety Management System Website for a church risk assessment on COVID-19.

Church facilities:

- Churches with venues (church & hall) **bigger than 200 square meters** must follow the **one person 4 square meters** rule, and always keep **1.5m distance** when moving around and interacting with other people.
- Churches with venues (church & hall) less than 200 square meters must follow the one person 2 square meters rule, and always keep 1.5m distance when moving around and interacting with other people.
- A maximum total of 50 people are allowed per venue (church & hall)
- Churches who wish to facilitate a gathering of more than 50 per venue (church & hall) must follow the <u>COVID Safe Industry Plan for Places of Worship in Queensland</u>.
- People from the **same household** should be allowed to sit together and groups of households kept separate.

Key Public Health Rules to continue:

- If unwell, stay at home
- Physical distancing 1.5meters between people at all times
- Hand hygiene (washing hands or using alcohol based sanitiser)
- Respiratory hygiene (coughing or sneezing into elbow)
- Tracking, tracing, rapid response (keeping contact details for 56 days for each service)
- Frequent environmental cleaning and disinfection

Church Singing:

• Singing is permitted during services, with the same distancing requirements listed above, based on your venue size.

Church Pre and Post Service Gatherings:

 People may gather before or after a service, however the place of worship will need to ensure that the gatherings are guided by the Industry <u>COVID Safe Plan</u> and that public health controls are followed

Church Communion Services:

- Churches may conduct communion service avoiding direct physical contact where practical. Where this is not practical, limit contact to hands. Ensure participants' hands are washed with hand sanitiser before and after each interaction.
- Consider holding Agape meals (no foot washing)
- All church members to give adequate time for attention to hygiene practices before and after the communion.
- If foot washing, Wash hands after foot washing for 20 seconds and dry thoroughly and follow up with hand sanitiser.
- Pastors and Elders breaking and distributing the emblems (bread and wine) are advised to wash hands as indicated above, use a hand sanitizer and wear gloves.
- Use dispensable communion cups
- Place individual bread pieces in dispensable wraps or cups (i.e. small paper cupcake cups)
- Practice proper disposal of communion cups and use gloves.
- If Pastors, Elders, Deacons or Deaconesses are suffering from a cold or flu symptoms, they should not be serving communion.

Church Shared Luncheons / Potluck lunches:

- These are prohibited.
- Church members wishing to stay together for lunch, must bring their own packed lunch boxes/family picnic boxes and eat only their own lunch. Under no circumstances should lunches and drinks be shared between individuals of different households. Lunches can be eaten in the church hall or in the park, however disposable cutlery should be used. Church kitchens are to remain closed. Clean and disinfect tables after use.

Church Record of Attendance:

- All persons attending Board meetings, business meetings, any programs, activities or events during the week and church service must be recorded. The following information is required
 - o Date
 - o Full Name
 - o Address
 - Contact number and Email address
 - Consider using online free booking system

Children's Sabbath Schools and Adventurer or Pathfinder Activities:

- Sabbath Schools and other children's programs run under the same requirements as Adults
 - 1.5m physical distancing at all times
 - Physical distancing 1.5meters between people at all times
 - Hand hygiene (washing hands or using alcohol based sanitiser)
 - Respiratory hygiene (coughing or sneezing into elbow)
 - Tracking, tracing, rapid response (keeping contact details for 56 days for each service)
 - o Frequent environmental cleaning and disinfection
 - All SQC and AdSafe policy, procedures and guidelines apply

• **Note:** the Church environment is not the same as the School Environment and therefore cannot be treated the same way.

Weddings & Funerals:

- A maximum of 100 people depending on the size of the venue 1 person per 2 square metres, up to 50 people for venues or spaces of 200 square metres or less, and no more than 1 person per 4 square metres for venues or spaces of more than 200 square metres.
- No buffet meals allowed
- No shared food or drinks to be served

Church facility cleaning:

Church facilities must be cleaned on a regular basis (before and after service, and during services)

- 1. The following **checklists** may be used to support churches:

 - d. Health, hygiene & facilities <u>checklist</u> COVID-19:

Tithes and Offerings:

Currently, churches are encouraged to give via the flexible tithe and offerings as outlined:

- Access to Electronic Giving (e-giving) via the internet website
- Access to e-giving by the new APP that can be easily downloaded to your mobile phone and/or ipad
- Details on Manal Credit Card Sheet that can be completed and emailed to us to allow for giving via credit or debit cards
- Access to Phone Service, should you wish to phone your credit card details through for our staff to assist you in your tithes and offerings
- Details for Direct Bank Transfers to our Conference bank account, should you
 prefer to give in this way
- Details on a personal Deposit system, available here at our Administration and Resourcing Centre (Spring Hill)
- Details on Mail Delivery for giving donations

For churches who wish to take up tithes and offerings at church, place offering boxes or baskets in convenient places, so members can leave their offerings without handling an offering bag that others have handled.

Treasurers who are counting and handling cash must wash their hands thoroughly after contact with cash.

General Precautionary Standards apply at all times, which include:

• washing your hands often and thoroughly with regular soap and water for at least 20 seconds

- using a tissue to cover your mouth or cough and sneeze into your elbow
- avoiding close contact with others, such as touching and shaking hands
- Discard used tissues in a bin or bag immediately and wash your hands immediately
- Don't touch your eyes, nose, or mouth with unwashed hands
- Frequently clean and disinfect regularly used surfaces and public areas, such as hand rails, door handles and benches
- Maintain social distance at all times with a distance of at least 1.5 meters between yourself and the next person (for public interactions)
- Stay home, self-quarantine and call your doctor if you feel unwell

Private Home Gatherings:

- Home owners hosting gatherings are expected to ensure homes are cleaned and sanitized
- Maximum of 100 family and friends allowed
- Household members and visitors are to:
 - o confirm if they are healthy and no fever
 - maintain 1.5m social distancing
 - o follow general precautionary standards listed above

Church service live-streaming and recording:

- Follow SQC230.002.ADM Church Low Risk Or Common Activities Risk Register at all times
- Follow social distancing practice by keeping 1.5m 2m distance at all times
- Follow General Precautionary Standards listed above
- Frequently clean and disinfect regularly used surfaces and public areas, such as hand rails, door handles and benches
- If hand sanitizers (hand gels or sprays) are not available then wash your hands every 20 minutes (take a break)
- Clean or sanitize any equipment, tools or stationary that is shared between people using sanitizing (alcohol) wipes. Cleaning and sanitizing must be done each time before a new person uses these items:
 - \circ Microphones
 - Headsets/ head pieces/ ear pieces
 - o Pens, clip boards, folders
 - Electronic screens, mobile phones, ipads or anything similar
 - o Other electronic equipment that may be used
 - Sanitize (with spray and wipe bottle or wet wipes) shared surfaces. Cleaning and sanitizing must be done each time before a new person touches or uses these items:
 - Tables and or benches
 - Chairs
 - Hand rails and door knobs

Convention Centers / Camp sites

The centers are open for Family camping, Caravan and Accommodation options following State Government Guidelines.

ABC Bookstores

ABC book centers are open. All customers are expected to sanitise their hands prior to entering the stores and follow 1.5m social distancing rules with limited number of customers permitted in store.

Coronavirus cases update

Today, one new case has been recorded. Queensland's total confirmed cases of Coronavirus is 1,089, an increase by 13 since our last cases update. Currently, Queensland has 11 active cases, 40 community transmissions, 4 hospitalizations, 0 in ICU and 6 deaths.
